1 LEGAL PROPERTY DESCRIPTION
 Legal description, code, class, size & physical address

2 OWNERSHIP AND MAILING ADDRESS
 You are responsible for updating your mailing address.
 Please note any address changes on the back of the payment stub and include with your payment.

3 PROPERTY VALUES
Real market value (RMV) is the assessor's estimate of the price your property would sell for as of Jan. 1st.
Assessed value for most properties is 3 percent more than last year's assessed value.
Exemptions if you have been approved for disabled Veteran or surviving spouse exemption, the amount will show on this line.
Net taxable is the less of the RMV or Assessed value minus any exemptions. Taxes are calculated on this amount.

4 IMPORTANT MESSAGES
 This area list if a mortgage company has received a copy of your bill or any notice such as bankruptcy, exemptions, etc.
 Phone numbers for tax or assessment questions.

5 TAX PAYMENT AMOUNTS AND DUE DATES
 Taxes may be paid in full, two-thirds, or one-third installments. Amounts are due Nov. 15, Feb 15, and May 15 of each year. (if any of the above days falls on a holiday or weekend, the due date moves up to the next business day)
 Payment in full qualifies for a 3% discount if made by Nov 15. Two-third payment qualifies for a 2% discount if made by Nov 15. One-third payments do not receive any discounts.
 If any of the payment options are not made by each due date, interest accrues on the account.

6 TAXING DISTRICT LEVIES
 This section displays the taxes levied for each of the districts in which your property is located. Each district collects a permanent tax rate for ongoing services plus any additional taxes that have been approved by the voters.

- A) Education Taxes
- B) General Government Taxes
- C) Bonds

7 DELINQUENT TAXES
 This section shows the amount of tax and interest owed including prior years. Payments will be applied to oldest tax year first.

8 TOTAL TAXES DUE (after discount)
 The amount shown reflects a 3% discount on the current year. Payment must be postmarked/received by Nov 15, 2017.
