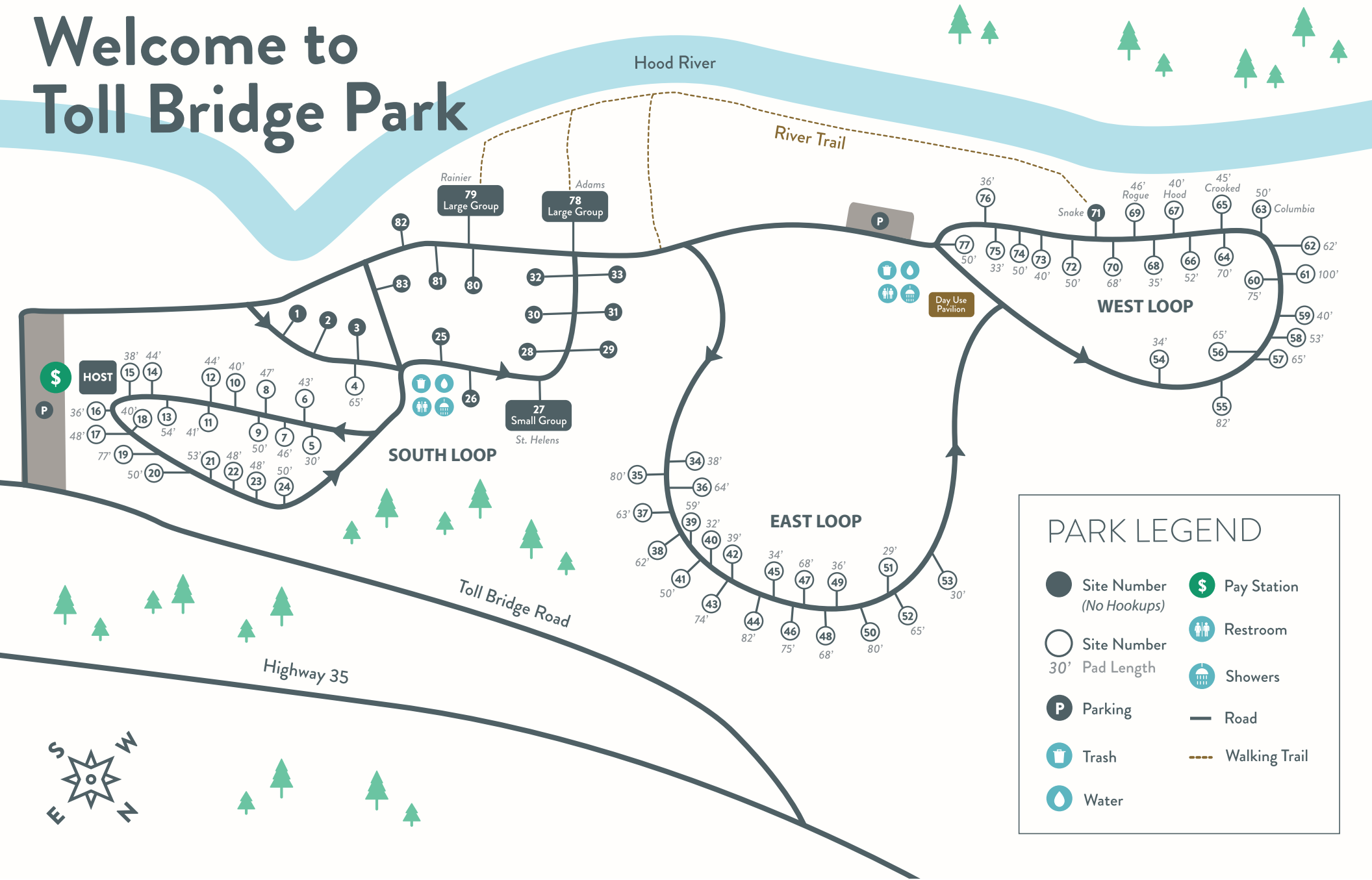


Welcome to Toll Bridge Park

HOOD RIVER COUNTY PARK RULES AND POLICIES

Check-in

Check-in time is after 12:00 p.m. the day of arrival. Vacant sites may be occupied earlier but sites that were purchased the day before may remain occupied until 12:00 p.m.

Check-out

Check-out time is by 12:00 p.m. the day of departure. Please make arrangements with a Campground Host prior to 9:00 a.m. if planning to stay additional nights. Be advised the same site may not be available for additional nights.

Site Occupancy and Stay Limits

All sites are subject to a maximum four (4) person per site limit, children not included, unless otherwise noted and a maximum seven (7) day stay limit.

Operating Hours

Picnic shelters and day-use areas are open during daylight hours only between Apr. 1 and Oct. 31. Camping areas are open to the public between May 1 and Oct. 31. Both day-use and camping areas are closed to the public all other times.

Quiet Hours

Please observe the established Quiet Hours between 10:00 p.m. and 7:00 a.m. All noise-making devices, including generators, are required to be operated in a manner that is not disturbing to other park users. Violators may be required to leave the park.

Lawns and Grass Areas

To preserve lawns and grass areas, the placement of tents, rugs, or other items may be restricted in certain areas, and/or may be required to be moved after 2-3 days. Restrictions may not be consistent between campgrounds or campsites and may depend on weather and/or lawn conditions. All restrictions are at the discretion of Hood River County staff. Be advised that lawns and grass areas are sprinkler irrigated and may result in you or your property getting wet.

Vehicles

Hood River County reserves the right to limit the number of vehicles allowed per site and their parking location. Vehicles must not block any part of roadways, fire lanes or adjacent campsites. Vehicles must be parked in designated parking areas only. Bicycles are permitted on roadways only. Speed limit is 10 MPH.

Visitors

Day or night visitors must check-in with Campground Host.

Children

Parents are responsible for their children's safety and behavior at all times. Please supervise children in the restrooms and do not allow children to play in the roadway.

Pets

Pets must be secured by a leash at all times and may not be left unattended, tethered to utility fixtures, picnic tables, trees, posts, fences, play structures, etc. or allowed to dig holes. Pet waste is required to be picked up by the pet owner. Violators and owners of questionable pets may be required to leave the park.

Restrooms and Showers

Restrooms and pay-showers are available throughout the park. Please see a park map or Campground Host for locations.

Laundry

Please do not hang clothes on lines or trees at the campsite.

Screenings

Please do not hang tarps, sheets or screens within a campsite.

Metal Detectors

The use of metal detectors is prohibited in all park areas.

Garbage

Please deposit all garbage in the dumpsters located throughout the campground. Complimentary garbage bags may be obtained from the Campground Host.

Trees

Trees may pose a natural hazard during normal or extreme weather conditions. Hood River County assumes no liability for such hazards or for any property damage, injury or other circumstance that may occur.

Fireworks

Fireworks are strictly prohibited at all times.

Fires and Smoking

Hood River County reserves the right to prohibit campfires and other fires of any kind, at any time, including smoking, throughout the park without notice. Please observe all fire restrictions.

Weapons

Possessing weapons such as firearms, knives, chains, etc. outside a personal vehicle is strictly prohibited.

Alcohol

The possession or consumption of alcohol is permitted within the park subject to all local and state laws, including those pertaining to public intoxication or public nuisance ordinances. The sale of alcohol within the park is strictly prohibited.

Theft/Damage

Hood River County is not responsible for loss, damages or claims to property of guests due to fire, theft, accident, or any other cause.

Condition of Premises

No premises shall be defaced in any form and are to be returned to their pre-use condition upon leaving. Any damage by a guest may result in the county seeking to recover costs incurred returning them to their original condition.

After-Hours Assistance/Security

Courtesy phones are not located in the campground. If emergency assistance is required, immediately call 911 from the nearest available cell phone and notify a Campground Host.

Right to Enter

Hood River County reserves the right to enter any campsite or shelter while in use in order to manage the property and enforce applicable laws, rules, regulations, policies and terms or conditions.
